Certificate(s) of Insurance – Blanket Coverage

The Bradenton Area Film Office has established insurance and certificate of insurance requirements for those filming in our area. Before filming can begin, a certificate of insurance must be furnished which includes the following:

<u>Specific date(s) of the event</u> must be stated clearly on the certificate, if blanket coverage is not already in effect.

<u>Type of Insurance Required</u>: General Liability and Occurrence should be checked. These are the minimum amounts required:

- Each Occurrence = \$1,000,000 or more
- Damage to Rented Premises (Each Occurrence) = \$50,000 or more
- Personal & Adv Injury = \$250,000 or more
- General Aggregate \$2,000,000 or more

Description of Operations:

- Manatee County, a political subdivision of the State of Florida is named as Additional Insured. AND
- The particular municipality where filming is taking place must also be named as Additional Insured. (See addresses below)
